ARTICLES OF INCORPORATION

OF

TARY OF STATE FRIENDS OF THE CUMBERLAND COUNTY PUBLIC LIBRARY, INC.

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Atticles of Incorporation for the purpose of forming a nonprofit corporation under and by virtue of the laws of the State of North Carolina.

ONE

The name of the Corporation is Friends of the Cumberland County Public Library, Inc.

TWO

The period of duration of the corporation is perpetual.

THREE

The purposes for which the corporation is organized are:

- A. To maintain an association of persons interested in books: to create an awareness of the opportunities offered by the Libraries of Cumberland County; to increase their facilities and service; to focus attention upon library needs: and to enrich the cultural advantages available to the citizens of Cumberland County.
- B. To include the securing of materials which are beyond the command of the ordinary library budget and the sponsoring of such projects as discussion groups, lectures, exhibits, book talks and to stimulate endowments and bequests.
- C. To perform all acts and do all things which may be incidental and necessary to the carrying out of the above objects and purposes and in order to properly prosecute the objects and purposes above sot forth, the corporation shall have full power and authority to purchase, lease and otherwise apply, hold mortgage, convey and otherwise dispose of all kinds of property, both real and personal, both in this state and all other states, territories, and dependences of the United States, and generally to perform all acts which may be deemed necessary for the proper and successful prosecution of the objects and purposes for which the corporation is created.

FOUR

The corporation shall have members which may be divided into such classes as shall be provided in the By-Laws. All members shall be accepted, appointed, elected or designated in the manner provided in the By-Laws.

FIVE

The Directors of the corporation shall be elected by the members in the manner provided in the By-Laws.

SIX

No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon dissolution of the corporation the assets thereof shall, after all of its liabilities and obligations have been discharged or adequate provision made therefor, be distributed to any association or association organized for purposes similar to those set forth in Article Three hereinabove, all as more particularly provided in the By-Laws of the corporation.

SEVEN

The address of the initial registered office of the corporation in the State of North Carolina is 301 May Street, Fayetteville, Cumberland County, North Carolina; and the name of its initial registered agent at such address is C. David Warren.

EIGHT

The number of Directors constituting the initial Board of Directors shall be seven (7); and the names and addresses of the persons who are to serve as the initial Directors are:
